

**GIFT AID DECLARATION**

I would like the Friends of Anne of Cleves House to treat all membership subscriptions and donations I make from the date of this declaration as Gift Aid donations, until notified otherwise. I am a UK taxpayer and understand that if I pay less Income Tax and/or Capital Gains Tax in the current tax year than the amount of Gift Aid claimed on all my donations, it is my responsibility to pay any difference.

**NOTES**

1. Only the first person named on the membership form will be eligible for Gift Aid.

2. You must pay an annual amount of income tax and/or capital gains tax at least equal to the tax that we reclaim on your donation in the tax year (currently 25p for each £1 you give).

3. You may cancel this declaration at any time by notifying us.

4. If in the future your circumstances change, and you no longer pay tax on your income and capital gains tax equal to the tax we reclaim, you can cancel your declaration (see note 2).

5. If you pay Income Tax at the higher or additional rate and want to receive additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.
